Public Protection Task Force (PPTF) – Hiring PT Research Consultant

The Board's PPTF has been working on analyzing the request by APTA NC to update Board rules related to imaging. The Chair of the PPTF, Board staff and Attorney met with the NC Medical Board and Chiropractic Board representatives in separate meetings in March and April, 2022. These meetings resulting in the necessity to obtain additional information and feedback from stakeholders related to this issue. It was proposed that a third-party familiar with the issue perform the research and provide information to stakeholders and return a report and communication to the Board with the results. Salary for the position prior to FY2023 is proposed as \$6-7,000 for Board approval.

Monitoring Program for licensees with substance use disorders

In January, 2022, the NC Board of Nursing was no longer able to offer an MOU for Disciplinary and Non-disciplinary monitoring for substance use disorders to the NCBPTE, Board staff researched options for a replacement program. Discussions were held with the NC Professionals Health Program (NCPHP) who offer similar services to the NC Medical Board, Board of Pharmacy and Veterinary Board. A proposed MOU was created between NCBPTE and NC PHP and was reviewed by the Board for approval. The program is designed to assist licensees to return to the unimpaired, competent practice of physical therapy. The Board investment of \$7,500.00 per licensee will be paid from licensure fees to offset the cost of licensee participation. The program fee will be paid for NCBPTE referred licensees; however, licensees wishing to obtain resources may contact NCPHP and will be assisted with finding resources.
