NC Board of PT Examiners Report at the NCPTA Business Meeting Radisson Hotel, High Point, NC October 11, 2008 By Ben F. Massey, Jr., PT, MA, Executive Director

1. **Purpose of the Board:** Reminder of the purpose of the Board is to regulate the practice of physical therapy in order to protect the health, safety, and welfare of the citizens of North Carolina. The next meeting of NC Board of PT Examiners is scheduled for Wednesday, December 04, 2008.

2. **Appointments to the Board:**

The 2009 Ballots for appointment of two (2) physical therapists and one (1) physical therapist assistant were mailed in early August with a return deadline of September 12, 2008. The ballots were counted at the NCPTA Headquarters on September 18, 2008 and the candidates for appointment were forwarded to the Governor on September 24, 2008.

2. Continuing Competence: In response to the passage of the continuing competence legislation by the North Carolina General Assembly in July, 2006, the Board has developed proposed rules which were posted on the Board's web page in mid July, 2008 and also published in the NC Register on August 1, 2008 (Vol. 23, Issue 03). A Public Hearing was conducted on August 28, 2008 at the Siena Hotel in Chapel Hill, NC and written comments have been accepted from August 15, 2008 – October 1, 2008. The Board incorporated suggestions it received into the version that was adopted on August 28, 2008. The proposed rules, as adopted by the Board, will be submitted to the Rules Review Commission (RRC) for consideration at its next meeting, which is scheduled for November 20, 2008. If the RRC approves the Rules, the effective date for implementation will be January 1, 2009. In addition to the program on the new continuing competence regulations that was presented at the NCPTA Chapter Meeting on October 10, 2008, there will be six (6) other programs presented across the State to discuss and explain the new requirements. Information regarding the programs can be located at the Board's web page (www.ncptboard.org).

Stu MacRoberts, PT, Board Member was appointed to serve on the Federation of State Boards of Physical Therapy's Continuing Competence Committee.

- 4. <u>Chemical Dependency Program:</u> In 2007, The Board entered into an Agreement with the North Carolina Board of Nursing (BON) for the BON to provide services on a contractual basis for a chemical dependency program for physical therapy licensees as an alternative to disciplinary action. The PT Board has consulted with the Board of Nursing regarding three (3) licensees. One (1) licensee has entered in the voluntary Alternative Program to Disciplinary Action.
- 5. Jurisprudence Exercise One & Two: To ensure that new licensees are familiar with the North Carolina Physical Therapy Practice Act, Board's rules, and position statements, all applicants who apply for licensure after January 1, 2007 will be required to complete an online jurisprudence exercise (Jurisprudence Exercise One). Current licensees may also complete the jurisprudence exercise and will receive a certificate for 1 contact hour. In 2009, Jurisprudence Exercise Two will be available for licensees to complete and learn more about the new continuing competence requirements. One (1) contact hour will be awarded for successfully completing Jurisprudence Exercise Two.


