1. **Purpose of the Board:** The purpose of the Board is to regulate the practice of physical therapy in order to protect the health, safety, and welfare of the citizens of North Carolina. The next meeting of NC Board of PT Examiners is scheduled for Wednesday, December 14 2016.

2. **Appointments to the Board:**

The 2017 Ballots for appointments of one (1) physical therapist and one (1) medical doctor were mailed in late July, 2016. On September 6, 2016, the ballots were counted at the NCPTA Headquarters and the candidates for appointment were forwarded to Governor Patrick McCrory on September 12, 2016 by C. David Edwards, DPT, NCPTA President. There are still outstanding appointments for one (1) physical therapist and one (1) physical therapist assistant for 2016. In addition to the aforementioned appointments, the term of the Public Member expires December 31, 2016 and will be up for appointment beginning January 1, 2017.

The Board would like to thank David Reed, PT, for his service to the Board from 2014 - 2016, and also for serving as Board Chair in 2016. The Board would also like to thank Stuart W. MacRoberts, for his service to the Board in 2016, completing the unexpired term of the Public Member. A special thanks to Michael Fajgenbaum, MD for serving on the Board from 2005 – 2007 and from 2014 – 2016.

3. **Online Renewal:** Licensees are required to renew their licenses <u>online</u>. Postcards will be mailed prior to November 1, 2016 informing licensees that the renewal period will be open online from November 1, 2016 until January 31, 2017 at 12:00 a.m. (midnight) and that online renewals will require a major credit card. Licensees not wanting to use a credit card will be given the option to renew online, but pay by check or money order. (The Board <u>strongly</u> recommends that licensees renew online by January 15, 2017 to ensure timely processing. The renewal cost is \$100.00.)

4. Continuing Competence – Fall 2016 Update

Continuing Competence Audits: Audits for the <u>January 1, 2014 - January 31, 2016</u> reporting period are complete, including PT and PTA licensees. As a result of auditing for this reporting period, one (1) licensee was issued an Advisory letter, and one (1) licensee was issued a Warning.

NCBPTE and NCPTA - Course and Provider approvals:

Communications continue between NCBPTE and NCPTA staff and PDCC as needed related to NCPTA Approved Providers and Board's rules interpretations. NCPTA approved provider activity Attendance forms are regularly submitted to the Board office in compliance with Board's rules.

5. Board's Rules

The Rules Committee of the Board convened August 11, 2016. Feedback to the Board is welcome regarding all rules. Relevant topics being discussed include: Continuing Competence, changes to Fees, PT educated taking the PTA exam, Licensure Compacts, Investigations and Complaints – accepting anonymous complaints among other topics posed by licensees and staff.

6. **Newsletter:** The Newsletter will be posted on the Board's website in mid-December, 2016. The Newsletter will include: Reflections from retired Executive Director, Ben F. Massey, Jr., PT, and other information and articles including those by John M. Silverstein, Board Attorney, regarding the NC State Legislature and Occupational Licensing Boards, David C. Reed, PT, Board Chair regarding Licensure Compacts, Debbie Ragan, PT, NCBPTE Deputy Director regarding the status of the continuing competence requirements since their inception in 2009.


