NC Board of PT Examiners Report at the NCPTA Business Meeting Marriott Airport Hotel, Greensboro, NC October 20, 2007 By Ben F. Massey, Jr., PT, MA, Executive Director

1. **Purpose of the Board:** Reminder of the purpose of the Board is to regulate the practice of physical therapy in order to protect the health, safety, and welfare of the citizens of North Carolina. The next meeting of NC Board of PT Examiners is scheduled for Wednesday, December 12, 2007.

2. **Appointments to the Board:**

The 2008 Ballots for appointment of one physical therapist and one physician were mailed in mid August with a return deadline of September 14, 2007. The ballots were counted at the NCPTA Headquarters on September 29, 2007 and the candidates for appointment will be forwarded to the Governor in November, 2007. In 2008, there will also be an appointment by the Governor of a Public Member and a physician.

In response to requests from licensees for additional information about nominees who are potential appointees by the Governor, the Board obtained basic biographical information regarding each nominee who had consented to serve. The biographical form is fairly simple and straightforward to keep the playing field level.

Continuing Competence: In response to the passage of the continuing competence legislation by the North Carolina General Assembly in July, 2006, at its Board Meeting on September 19, 2006, the Board passed a motion to appoint an Advisory Panel for Continuing Competence. The Advisory Panel to the Board consists of 3 Board members, 1 former Board member, and 3 members of the NCPTA. (The Board solicited a non-NCPTA member, but no one volunteered.). The Panel is assisted by John Silverstein, Board Attorney, and Ben Massey, Executive Director, who also serves as Facilitator. The purpose of this panel is to study the various options available for Continuing Competence and make recommendations to the Board. The Advisory Panel will not have authority to adopt rules as this is the responsibility of the Board. The Panel has conducted two (2) meetings and has two (2) more meetings scheduled. The Panel will present its recommendations to the Board for consideration at the June, 2008 Board Meeting.

Massey and Silverstein conducted eleven (11) Forums across the state to allow licensees to voice their opinions regarding Continuing Competence. The comments from the Forums were recorded and shared with the Advisory Panel. In addition, comments received at the Board office via email have been shared with the Advisory Panel.

4. <u>Chemical Dependency Program:</u> In 2007, The Board entered into an Agreement with the North Carolina Board of Nursing (BON) for the BON to provide services on a contractual basis for a chemical dependency program for physical therapy licensees as an alternative to disciplinary action. The PT Board has consulted with the Board of Nursing regarding three (3) licensees. One (1) licensee has entered in the voluntary Alternative Program to Disciplinary Action.

- 5. <u>Jurisprudence Exercise:</u> To ensure that new licensees are familiar with the **North Carolina Physical Therapy Practice Act**, Board's rule, and position statements, all applicants who apply for licensure after January 1, 2007 will be required to complete an online jurisprudence exercise. Current licensees may also complete the jurisprudence exercise and will receive a certificate for 1 contact hour.


