

NC Board of PT Examiners Report - NCPTA Business Meeting Wilmington Convention Center Wilmington, NC October 4, 2019 By Kathy O. Arney, PT, MA, Executive Director

Purpose of the Board: The purpose of the NC Board of Physical Therapy Examiners is to regulate the practice of physical therapy in order to protect the health, safety, and welfare of the citizens of North Carolina. The next meeting of the Board is scheduled for Wednesday, December 11, 2019.

1. **Appointments to the Board:**

The 2020 Ballots for appointments of one (1) physical therapist and one (1) Medical Doctor to the Board were mailed in late July, 2019 to all NC physical therapy licensees. On September 18, 2019, the ballots were counted at the NCPTA Headquarters, and the candidates receiving the greatest number of votes for each position were forwarded to Governor Roy Cooper by NCPTA for appointment for terms beginning January 1, 2020.

The Board would like to thank Mr. David C. Reed, PT, for his service to the Board from 2014-2019, including his service as Secretary-Treasurer in 2015, Board Chair from 2016-2019, member of the Finance and Audit Committee in 2015 and Investigative Committee in 2018. His Board participation extended to representing North Carolina as the Delegate to the Federation of State Boards of Physical Therapy Delegate Assembly in 2019. He is not eligible for reappointment to the Board.

The Board would like to thank Dr. Paul Garcia for his service to the Board from 2016-2019. His contribution was instrumental in creating the website posting regarding information to licensees who may require assistance from substance use disorders. He is eligible for reappointment.

The Board would also like to thank Mr. Stuart W. MacRoberts, Public Member, for his service to the Board from 2015-2019. His insights regarding physical therapy as a member of the public have contributed to the Board fulfilling its public protection mission. He is eligible for reappointment.

Current Board members will continue to serve until appointments are made by the Governor.

2. **Online Renewal:** Licensees are required to renew licenses <u>online</u>. Postcards will be mailed prior to November 1, 2019 specifying that the renewal period will be open online from November 1, 2019 until January 31, 2020 at 12:00 a.m. (midnight) and will require a major credit card. Licensees not wanting to use a credit card may renew online, but payment by check or money order must be postmarked by the January 31 midnight deadline. (The Board <u>strongly</u> recommends that licensees renew online by January 15, 2019 to ensure timely processing. The renewal fee is \$120.00 plus the cost of credit card processing.)

3. Continuing Competence – Fall 2019 Update

Continuing Competence Audits: Audits for the <u>January 1, 2017- January 31, 2019</u> reporting period are ongoing, including PT and PTA licensees selected at random. Licensee response to audit requests are required within 30 days.

4. 4. Board's Rules:

• **Periodic Review of Rules:** Every 10 years, Occupational Licensing Boards must undertake a thorough review of existing rules to see if changes need to be made, or if rules have substantive public interest. The three rules found to have substantive public interest are:

21 NCAC 48F .0102- Fees

21 NCAC 48F .0103- Complaints

21 NCAC 48G .0504- Complaints and Investigations

A public comment period was followed by a public hearing at the Board's meeting on December 11, 2018. Thee three rules were re-adopted without substantive changes, became effective May 1, 2019 and have been entered into the NC Administrative Code. The Periodic Rules Review process for this 10-year cycle is now complete for the NCBPTE.

- Rule Technical Changes: Technical changes to Board Rules are any addresses, website links, or punctuation errors that do not involve changes to the intent of a rule. Due to re-codification of the NC PT Practice Act in October 2017, all of the updated statute numbers were changed in the body of the Board Rules effective September 1, 2019 and are now in the NC Administrative Code.
- Permanent Rulemaking: The Board Rules Committee will continue to review and update rules in response to National Physical Therapy Exam eligibility requirements and other relevant topics. Feedback to the Board regarding all rules is welcome at any time.

- 6. **Status of Dry Needling in NC post-Lawsuit:** On December 8, 2018 the North Carolina Supreme Court issued its ruling in the North Carolina Acupuncture Licensing Board (NCALB) vs. North Carolina Board of Physical Therapy Examiners. The Supreme Court upheld the Physical Therapy Board issued declaratory ruling on June 27, 2016, stating that trigger point dry needling is within the PT scope of practice in North Carolina. The NC Supreme Court Ruling and NCBPTE Declaratory Ruling are posted on the Board website under the "Announcements" page for reference. In summary, the Board has determined dry needling is an advanced skill for which training beyond entry level education is required. It is incumbent upon the licensee to obtain the appropriate training, education and be competent to perform trigger point dry needling. There is no longer a position statement and there are no specific requirements for the education and training required for performing trigger point dry needling by a physical therapist licensee.

8. Licensing – Compact Privilege Issuance Updates

a. Physical Therapy Licensure Compact

The PT Compact Commission began issuing "privileges to practice" in North Carolina on July 1, 2019. North Carolina joined fifteen (15) states currently issuing privileges. As of September 19, 2019, eighteen (18) Compact Privileges have been issued for NC. For more information about eligibility for or obtaining a privilege in member states or the PT Compact Commission in general, go to: ptcompact.org.

In compliance with the Compact law, NCBPTE must require FBI Criminal Background checks for all initial licensure applicants. For additional information see the Board website under the Licensing tab or contact the Board office.

North Carolina continues to be represented on the PT Compact Commission by Kathy O. Arney. PT as delegate and Vice-Chair.


